RII20213 - Certificate II in Surface Extraction Operations

Certificate II in Surface Extraction Operations takes in the role of operators and contractors employed at entry level within open cut mines or quarries. Learning outcomes include training in specialised techniques and procedures that are used in the industry as well as statutory and legislative requirements, risk management systems and Workplace Health and Safety legal obligations.

RII30113 - Certificate III in Surface Extraction Operations

Certificate III in Surface Extraction Operations encompasses the role of employees such as production operators in an open cut mine who perform tasks including safe mining procedures and operating heavy equipment. Learning outcomes include training in specialised techniques and procedures that are used in the industry as well as statutory, legal compliance requirements, risk management systems and continuous improvement processes.

RII40213 - Certificate IV in Surface Coal Mining (Open Cut Examiner)

The Certificate IV in Surface Coal Mining (Open Cut Examiner) is one of the mandatory requirements for those wishing to undertake the role of Open Cut Examiner on a mine site. OCE's conduct tasks involving a wide range of varied activities most of which are highly in depth and non-routine. They are to manage the quantity and quality of the work produced by others and to contribute to the development of technical outcomes to non-routine problems that arise.

TAE40110 - Certificate IV in Training and Assessment

Certificate IV in Training and Assessment is the perfect opportunity for those seeking employment in a training environment within their industry. This course will provide you with the knowledge and skills to be able to prepare, deliver and monitor training and assessment activities.

Certificate IV in Training and Assessment will help you achieve this through topic areas such as, Learning Environment, Learning Design and Delivery and Facilitation.

Depending on your work requirements you are now able to choose up to four units which give you the opportunity to obtain one the following skills sets, should you not require the full qualification:

- Assessor Skill Set
- Enterprise Trainer Skill Set
- Enterprise Trainer & Assessor Skill Set
- Workplace Supervisor Skill Set

BSB40812* - Certificate IV in Frontline Management

Certificate IV in Frontline Management is the perfect opportunity for those aspiring to be a manager or those looking to enhance their managerial skills within their industry. This course will help develop your knowledge and skills so as to be able to carry out professional responsibilities, ensure organisational performance and business outputs. It will allow you to discover different tools and methods on how to provide leadership and guidance to your employees. It includes contemporary computing packages, customer services skills as well as teamwork and communication.

BSB41415 - Certificate IV in Work health & Safety (WHS)

This course has been specifically designed to develop knowledge and skills required for working in a work health and safety (WHS) role who may or not work under supervision. It is a necessary qualification for those responsible to maintain a safe and healthy workplace. It equips health and safety professionals, supervisors, safety coordinators, advisors and facilitators, safety officers, safety representatives and safety committee members for their respective roles.



SAFETY TRAINING

S1, S2, S3 + G2 Site Supervisor Safety Course

Pegasus provides individual and custom training programs to meet your training requirements in a number of competencies from the RII Resources and Infrastructure Industry Training Package. The S1,S2,S3 + G2 training program has been developed for participants employed in the mining, construction and civil industries. Anyone who performs the duties of a mine supervisor, or holds the position requirements of a Mine Supervisor or Safety & Health Representative will require these enhanced skills to implement on site Work Health and Safety management systems as dictated by legislation.

Health and Safety Representative (HSR) 5 Day Course

This five day course will provide deemed HSRs with additional information and skills required for HSRs under the new WHS legislation including:

- an understanding of the new Work Health and Safety legislation;
- an understanding of how it applies
- to their role as elected Health and Safety Representatives (HSR); and
- the additional knowledge and skills necessary to use their new powers under the new WHS legislation in issuing Provisional Improvement Notices and directing unsafe work to cease.

The course is intended to assist HSRs and deputy HSRs understand how the WHS legislation will influence health and safety outcomes in their workplace. The course aims to familiarise participants with the knowledge and skills necessary to fulfil their role as Health and Safety Representatives.

Health and Safety Representative (HSR) 1 Day Refresher.

As a Health & Safety Representative you will need to maintain your compliance with the one day refresher in line with legislation.

CPCCOHS1001A - Work Safely in the Construction Industry

This is a SafeWork NSW (previously WorkCover) mandatory requirement to be able to enter any construction site. It is a legislative requirement that all construction workers obtain a current WHS General Induction Card or "White Card" as it is commonly known in the industry. This qualification will enable you to work on a construction site in New South Wales and is recognised in all other States and Territories.
